| Brief Title | 1. This Regulation is named as " Final International University Student Scholarships and Discounted Tuition Fee ". |
| Scope | 2. This regulation covers the rights of the FIU students who have gained the right to receive scholarships or discounted tuition fees; the scope, amount, duration, conditions for the implementation and termination of scholarships, and discounted tuition fees. |
| Aim | 3. This regulation aims to; improve the education quality of FIU, reward successful students, and support students' interests in sports and arts. |
| FIU Entrance Scholarships | 4. Students who are placed in UFU's scholarship programs through the Higher Education Transition Exam (YGS), Undergraduate Placement Exam (LYS) or Vertical Transfer Exam (DGS) by the Measurement, Selection and Placement Center (ÖSYM), or students who are placed in scholarship programs determined by the decision of the Board of Trustees according to the entrance and scholarship exam organized by FIU for TRNC students, are exempt from the tuition fee at the scholarship rate of the quota they are placed in during their study periods. The scholarship covers only the exemption of the tuition fee. Students who leave the program in which they were placed will lose their scholarship rights. However, the status of students who transfer between similar programs is decided by the Board of Trustees. |

Priority Discount

5. (1) Students who are placed by The Measuring, Selection and Placement Center (OSYM) with their first three priority choices in the programs within the Faculty of Architecture and Fine Arts, Faculty of Economics and Administrative Sciences and Faculty of Engineering will be given a discount of 20% of the tuition fee which they are obliged to pay.
- (2) The aforementioned priority discount will be applied as 30% of the tuition fee they are obliged to pay to students who have graduated from Final Education Institutions or who have studied at Final Education Institutions in the last 1 year and who have the right to study at our university.

Academic Scholarship

6. With the exception of the preparatory class, associate and undergraduate students who have completed the first two semesters in the program they are enrolled in and have taken the normal semester course load specified in the program, provided that the semester grade point average (GPA) is 3.50 and higher out of 4.00 and the GPA (CGPA) is at least 3.00, students who rank as the first top 3 in the program are provided with a scholarship at a rate of 20% to 40% of the tuition fee they are required to pay. For students with the same grade point average (GPA), the ranking is made by considering the Cumulative Grade Point Average (CGPA). Students who have both the same Grade Point Average (GPA) and Cumulative Grade Point Average (CGPA) are eligible to get the scholarship in the same category.

First: 40%

Second: 30%

Third: 20%

Academic scholarships are for semesters and are evaluated at the end of each semester according to the criteria mentioned above.

Sports Discount

7. (1) Students from the School of Physical Education and Sports (BESYO) are given a discount of 10% on the tuition fee they are obliged to pay if they are licensed sports players for at least two years.
- (2) The discount is given to a sports player who has achieved first place individually or in teams in a sports event that he/she participated in representing FIU that is accepted by the Board of Trustees, or who is active in one of the FIU Sports Clubs and has become a national player in his/her country own, under the condition of maintaining active and successful involvement sports at the university.

Sports discounts are for two terms and cover the full or partial tuition fee.

The scope and conditions of the discount are determined by the Board of Trustees for each academic year with the opinions of the director of the School of Physical Education and Sports and the recommendation of the Rectorate.

- Discount for Siblings**
8. Siblings who study and are enrolled at FIU programs will receive a discount of 10% for each of the siblings that they are obliged to pay. After one of the siblings graduates, the discount for the other sibling continues.
- Discount for the High School Highest Ranking Graduate**
9. Students who have gained the right to register for a program at FIU within the year of graduation after having successfully completed a high school or an equivalent institution in TRNC as the highest ranking student with a graduation degree of excellent and students who have successfully graduated from a Turkish Republic high school as the highest ranking student, and who have been admitted to one of the undergraduate programs at FIU in the year of graduation by the Turkish Republic Higher Education Student Selection and Placement Board (ÖSYM) or with the high school highest ranking graduate quota receive a tuition fee scholarship of 25 %.
- Scholarship for the TUBİTAK and International Scientific Boards**
10. Students who have participated in The Scientific and Technological Research Council of Turkey (TUBİTAK) projects or International Science Olympics on behalf of TUBİTAK while at high school level and received gold, silver or, bronze medals in any of the fields of Mathematics, Physics, Computer, Chemistry, Biology are given scholarships up to 50% of the tuition fee they are obliged to pay.
- Discount for Nationals of The Republic of Turkey who have graduated from TRNC High Schools**
11. Citizens of the Turkish Republic who have graduated from a high school in TRNC and have registered at FIU have to pay the same amount of the tuition fee specified for the nationals of the TRNC.
- Discount for the Children of Martyrs**
12. A 100% tuition fee discount is applied to children of martyrs who are entitled to study at FIU.

Discounts for Final Educational Institution Students

13. Students who have graduated from Final Education Institutions or have been educated in Final Education Institutions in the last one year and are entitled to study at our university are given a 20% discount on the tuition fee they are obliged to pay. Together with the priority choice discount, this rate is applied as 30% as stated under article 5 (2) of this regulation.

Discounts for FIU and DMG Group Employees and their Children

14. DMG group and UFU employees, employees' spouses and their children are given a 20% discount on the tuition fee they are required to pay for each.

Discounts for the Disabled Students

15. With the approval of the Board of Trustees, TRNC nationals who have a disability degree of 40% and above and whose disability is certified by the relevant institutions are eligible to receive a 50% discount on the tuition fee they are obliged to pay under the conditions that they meet the entrance requirements to FIU.

Discounts for Education Staff and Security (Military and Police) Members

16. Teachers or lecturers (including retirees) and the children of the military and police who are placed in any undergraduate program of FIU by OSYM are eligible to receive a 10% discount on the tuition fee they are obliged to pay.

Scholarships for the Nationals of the Third Countries

17. These are the scholarships given to foreign students in accordance with the quotas and scholarship rates determined each year by the University Board of Trustees. These scholarships only cover the tuition fee.

Scholarship for Research Assistant

18. Scholarships are granted to research assistants who have been enrolled in postgraduate programs within the framework of the rules determined by the Rectorate and approved by the Board of Trustees.

A student with a scholarship who freezes the registration

19. It is evaluated within the framework of FIU Education, Examination and Success Statute under article 12.

- Discipline Application** 20. In case of disciplinary penalties, the decision on the application of the scholarship is made by taking the opinions of the Dean or the Director and, if approved by the Rectorate, then agreed by the Board of Trustees.
- Duration of Scholarships** 21. Scholarships (except for academic scholarships) and discounts continue throughout education duration.
- Multiple Discount Application** 22. A student cannot benefit from more than one scholarship and discount (except for the Entrance Scholarships for FIU and Third Country Student Scholarships. An additional discount is applied to these two scholarships.). Students who meet more than one discount criteria or criterion are given the most advantageous discount in favor of the student.
- Other Matters** 23. In cases that are not specified in this regulation or may occur during the implementation of the regulation and are not clearly stated in the regulation, the Board of Trustees may **make a decision** on the subject.
- Executive Authority** 24. This regulation is executed by the FIU Rectorate.
- Entry into Force** 25. This regulation comes into force as of the date approved by the Board of Trustees of Final International University.
